# TUMMY TICKLERS

From the inside of Norman Simpson's dutch oven comes the aroma of a very, very tummy pleasing peach cobbler. M-M-M-M

#### PEACH COBBLER

- 1 Orange cake mix (or lemon or chocolate or white)
- 1 #2-1/2 can sliced peaches
- l Small can (tuna fish size) crushed pineapple

Make up the cake mix with just the amount of water noted on the box--no eggs please. Into the bottom of the aluminum foil lined dutch oven, put half of this mixture. On top of this put the peaches and then spoon the crushed pineapple on top of the peaches (do not drain any fruit). Pour on the rest of the cake mix.

Cook for 15-30 minutes with twelve briquets under the dutch oven and 6 on the lid.

Test with a fork for doneness.


Spring Creek Chapter Meetings are held at Roundtable on the 1st Thursday at 7:30 p.m. at Holladay High School. Please come!!!

There will be a dance competition and ceremony competition.




