

MAKE A WOODEN WHISTLE

- 1. Begin with ½ x ½-inch pine. Cut to 3 inches length. Drill 21/4 x 1/4 inch hole in one end.
- 2. Measure 1/2 inch from end with hole and mark as shown. Measure another 3/4 inch and mark again.
- 3. Use coping saw to cut 1/2 inch deep at point A. Use sharp knife to carve angle out from B to A.
- 4. Shave about 1/32 inch off one side of 1/4-inch dowel, as shown. Cut 1/2 inch long. Glue and insert into hole. Adjust dowel until best whistle is obtained. Allow glue
- 5. Whistle is easily made into neckerchief slide by adding length of rawhide lace as shown.


ALUMINUM FOIL UTENSILS


Shown are two handy utensils that can be made from aluminum foil. It is recommended that heavy-duty foil be used. If heavy-duty foil is not available use two sheets of


Foil Cooking Container

Cut a square of foll, say, 12 x 12-inch. Fold two opposite corners to the center (1) then fold each of the folded parts in half to the center (2). Fold in half as indicated in 3. Insert forefingers in the pockets formed and ease out; fold the upright edges against the bottom edges to produce the creases shown in 4. Carefully pull down both pockets to give 5. Turn over and repeat on the other side, producing Fig. 5. Fold the three corners to the center, turn over and repeat on the other side (6 and 7), to produce 8.


Fold in half to give 9. Insert the foretingers in the openings indicated by the arrows and genily open out to give you your foll cooking container; complete with two "handles" (10).















Drinking Cup

- 1. Fold a square sheet of aluminum in half diagonally.
- 2. Fold corner "A" up to point "A-1" as shown. Turn over aluminum and repeat with corner "B."





- 3. Tuck corner "C" into the fold created by step 2. Turn over aluminum again and repeat with corner "D."
- 4. Open and use as cup. If made with paper this cup will hold cold liquid. With foil it will hold either cold or hot liquid.

National Scout Jamboree - ORDER OF THE ARROW SERVICE CORPS

The El-Ku-Ta Lodge #520 WWW has been given the opportunity to take eleven superior lodge members as OA service corps members to the 1981 National Scout Jamboree in Virginia. Any member who will be sixteen years of age by July 1, 1981, but not 18 before September 1, 1981 is eligible and should consider submitting an application for such position. In addition to these national requirements, our lodge has set a series of standards to insure that our lodge is exceptionally well represented. Our requirements dictate that an arrowman must be an Eagle Scout, an active and registered lodge member, must submit a letter of recommendation from his scoutmaster or sponsoring institution, and must submit a personal letter in which he describes why he wishes to attend, his awards and special scouting experiences, and a brief run down of what he can do for the group from our lodge (song leading, guitar playing, skit leading, etc.). The deadline for submitting an application is November 20, 1980. The group from our lodge will leave on July 19 or 20 by car bound for Virginia. Arrival at the Jamboree will be on July 27, Departure will occur on August 6. The group will then go to the National OA Conference in Austin, Texas for the 10-14 of August, and will finally return home on August 19 or 20, 1981. The total cost which includes food, transportation, lodging, Jamboree fees, and National Conference fees will be approximately \$600. Those selected plus three alternates will be notified by November 30, 1980. Clarification of Lodge Policies as printed in last months ECHO-Section IX should read:

THESE RULES SHALL BE SUBJECT TO AMENDMENT AT ANY REGULAR OR SPECIAL MEETING OF THIS LODGE, PROVIDED THAT SUCH AMENDMENT HAS BEEN SUBMITTED IN WRITING TO THE EXECUTIVE COMMETTEE AT LEAST ONE MONTH PRIOR TO SUCH MEETING AND THAT DUE NOTICE HAS BEEN SENT TO ALL ACTIVE MEMBERS AT LEAST TEN DAYS PRIOR TO SUCH A MEETING.

- A. VOTING ON AMENDMENTS TO THESE POLICIES SHALL TAKE PLACE ONLY AT A MEETING IN WHICH A MAJORITY OF THE CHAPTERS OF THE LODGE ARE REPRESENTED. AT SUCH MEETING, ALL LODGE MEMBERS UNDER THE AGE OF 21 SHALL HAVE ONE VOTE PROVIDED THEY ARE ATTENDING IN PERSON.
- B. VOTING ON OTHER MATTERS OF THE LODGE NOT DESCRIBED ABOVE SHALL TAKE PLACE IN AN OPEN MEETING IN WHICH A MAJORITY OF THE CHAPTERS ARE REPRESENTED. EACH CHAPTER CHIEF SHALL HAVE ONE VOTE, EACH ELECTED LODGE OFFICER SHALL HAVE ONE VOTE, AND EACH LODGE DVC SHALL HAVE ONE VOTE. IN CASE OF A TIE, THE LODGE CHIEF SHALL HAVE A SECOND VOTE.

Section III should read: (this portion represents a proposed amendment)

- A. Nö change

 - 3. THE HIGHEST VOTE GETTER AMONG THE VICE CHIEFS OF THE LODGE SHALL SUCCEED THE LODGE CHIEF IN CASE OF DEATH OR HIS INABILITY TO FULFILL HIS FULL TERM IN OFFICE. FOR SHORT LEAVES, THE LODGE CHIEF SHALL HAVE POWER TO APPOINT A SUBSTITUTE AMONG THE LODGE ELECTED OFFICERS. IN CASE OF A TIE IN VOTES FOR VICE CHIEF, THE EXECUTIVE COMMITTEE OF THE LODGE SHALL RENDER THE DECISION OF SUCCESSION.

These policies listed above shall be voted upon at the November twentieth meeting of the lodge. A special invitation is extended to the general lodge membership to come and vote at this regular business meeting. The general lodge membership is invited to any regularly scheduled lodge meeting throughout the year. - from time to time amendments will be brought before.
