The objectives of the Scouting movement are to develop boys into the young men of tomorrow. Through the ranks, Scouts learn the importance of leadership, duty to God, citizenship, and knowledge in a world that needs it. One of the main facets of developing this leadership is through the national organization of the Order of the Arrow, W.W.W.

The order of the Arrow normally takes a Scout after he has been in the organization over a year. He is just beginning to realize the true objectives of the Boy Scouts of America. As such, the young Arrowman is beginning to turn into a young man. Since the Order of the Arrow is an HONOR camping program, it only takes those men who "could forget themselves in serving others." This makes the man. After all, the Arrowman is the cream of the crop from his unit.

WHAT IS THE ORDER OF THE ARROW AND ITS FUNCTIONS?

It is the honor camping society for the Boy Scouts of America to recognize Scouts and Scouters who have exemplified the outing in Scouting the Scout Oath and Law in their daily life.

Its function is Service to the Council at camps, activities, such as Scout Fair, Beaver Dinner; to service their District; most important is service to their unit. They promote camping, both ling term and weekend. Aid the Unit Leader in leadership and extend a helping hand to the younger and new Scouts.

What does WWW mean? The Brotherhood of Cheerful Service.

What does EL-KU-TA mean? It is simply the name of our Lodge.

When are dues payable? By December 31st of each year. Dues may vary from year to year as established by the Executive Committee. Dues after January 1st are delinquent and a \$1.00 fee is added.

What are dues used for? To cover operating costs, such as your monthly newspaper (the Echo) which costs about \$600.00 a year to print and mail, National fees, awards and many functions subsidized by the Lodge.

What is the Lodge Council? Arrowmen elected by you and the membersh Members under 21 years of age only can be elected. Each Chapter or District is represented with a vote on the Lodge Council.

Why the need for a Lodge Council? The size of our Lodge (1300) makes the need greater to service our Council and outlying Districts.

Why do we have Chapters? To serve the Arrowmen in their own area because our Lodge is so large and covers a large territory. To stimulate program, service within a given area, mostly the district they are associated with. To give every member a voice in the Lodge.

What are the three parts of the Arrow? Ordeal Member - elected by the unit. Brotherhood - after 10 months service to the Order of the Arrow, Council, District and committing to memory the questionnaire given you, and passing a board of review. Vigil Honor - candidates selected by the Vigil Committee, Brotherhood members with two years of service to the Order of the Arrow, Scouting and community are then selected, forwarded to National office for approval. The Vigil Honor is something that can not be directly earned or sought - it is an HONOR bestowed upon an individual by the National Office.

Each month the "Echo" runs an article on an outstanding Arrowman, young man or adult. The best PROFILE will be chosen to appear in the "Echo" each month. Send article in before the 8th of each month to the Editor. Any Active Arrowman may submit a PROFILE about one of your fellow Brothers.

MEANING OF OUR LODGE PATCH - The Elk is the totem of our Lodge; the yellow the sun's rays shining over the Great Salt Lake; the blue symbolizes our smoggy skies; the red arrow is the national symbol of our Order; the name EL-KU-TA is a combination of the words: ELK and UTAH. The two Indians on the flap symbolize Brotherhood.

WEARING OF O/A INSIGNIA - Both the pocket flap and Arrow suspended from the and white ribbon should be worn on the right pocket. The flap and ribbon be worn on the uniform at all times. The white sash and neckerchief are tworn only at O/A functions or at special Lodge approved events.

NATIONAL STANDARD ORDER OF THE ARROW

With the BOYPOWER '76 program now in full swing with the Boy Scouts of America, it is most important for the Order of the Arrow to prove itself the true honor camping and SERVICE organization that it is. One way of proving itself is for each lodge in the United States to become a National Standard Lodge. Each year, the requirements for attaining this envied status is set down by the National Office. To qualify for National Standard Lodge status each year and to do its part in the BOYPOWER '76, a lodge must achieve the following goals:

- A. 50% of total lodge membership must qualify as Brotherhood members by the time of the Annual Lodge Charter Renewal.
- B. Camping Promotion Committee in each lodge to help carry out the council camping promotion plan.
- C. Hold an annual lodge (and Chapter) Officers' Training Conference.
- D. Have a current "Where-to-go-Camping" publication.
- E. Publish a regular (at least quarterly) bulletin or newsletter.
- F. Maintain current membership and financial records.
- G. Have representatives attend National O/A Conference and Area Fellowship Training Conferences.
- H. Hold annual membership elections in every eligible unit.
- I. Place emphasis on the following objectives:
 - 1. A Boy Scout or Explorer today, a Scouter tomorrow.
 - 2. Advancement beyond First Class.
 - 3. Each Arrowman to recruit one new boy into Scouting annually.
 - 4. Correct wearing of the uniform through personal example.
 - 5. Perpetuate authentic American Indian culture and traditions.
 - 6. Improvement of Ordeal, Brotherhood, and Vigil Honor ceremonies.
 - 7. Promotion of Professional Scouting as a career.

The Order of the Arrow must meet the challenge of BOYPOWER '76 by making sure that every Arrowman, every Chapter, and every Lodge is prepared to do their part.






MIKE ARMSTRONG LODGE VICE CHIEF

OPERATING COMMITTEES OF THE LODGE AND CHAPTERS

In order to reach the objectives of the Q/A it is necessary to have a number of committees. Lodge Committee Chairman are appointed by the Lodge Chief, just as Chapter Chairman are appointed by the Chapter Chief. The following committees are those which exist at all times in this Lodge and likewise exist in the Chapters. Some Chapters have more committees than what are listed below; this is just a minimum list. Every Arrowman should serve and be active on one or more committees. In this way, each member shares the responsibility for lodge activities and projects and lodge officers are not burdened with all the details of meeting lodge objectives:

SERVICE COMMITTEE - suggests a yearly schedule of service projects, gets lodge approval, and makes complete plans for getting the work done. The camping and activities committee representative is usually the committee advisor.

ACTIVITIES COMMITTEE - developes plans for three or four membership meeting activities for the lodge each year and is responsible for carryin them out. These include our annual activities such as the Spring Fellowship, the Fall Fellowship, and the Mother, Father, Son Banquet.

FINANCE COMMITTEE - draws up an annual budget; issues regular finance reports, obtaining its information from the council office; supervises the work of the treasurer; and is responsible for the financial status of the lodge.

UNIT ELECTIONS COMMITTEE - sends out information to unit leaders about elections, organizes and trains election teams, schedules visits of election teams to units, and receives and records the results of election

CEREMONIAL COMMITTEE - trains ceremonial teams, instructs members on costume making, keeps ceremonial grounds in good order, and conducts ceremonies and demonstrations for the lodge. In our Lodge the Ceremonial committee is broken up into three smaller committees of Ordeal, Brotherhood, and Vigil Honor, each committee being directly responsible for its own area.

MEMBERSHTP COMMITTEE - checks on inactive members and maintains membership records, sends out letters each year to determine active members and check address changes, sends letters to Ordeal members eligible for Brotherhood membership.

CAMP PROMOTION COMMITTEE - develops plans for camping promotion in consult with the camping and activities committee; develops promotion helps such a "Where to go Camping" booklets, visual aids, color slides, and movies of

camping activities. It is the advisor's job to provide training and coach

for the committee members. PUBLICATIONS COMMITTEE - responsible for assembling, editing, printing, an mailing the Elk's Echo, our monthly lodge paper. Assumes control of all

printing costs credited to the lodge and any special publications or mailings. All publications and mailings which are a cost incurred by the Lodge must be approved by the Publications Advisor; otherwise subject cost will be charged to the Chapter or to the individual.

COMMITTEE ON INTER-LODGE RELATIONS - consists of the committee Chairman, Lodge Chief, Past Lodge Chief, and an advisor. This committee travels to other Lodges and observes their methods of conducting meetings and activit Reports are submitted and new ideas are encouraged and often adopted. Members at large in the Lodge, usually Chapter Chiefs or other prominent L
